



## Babcock Ranches Stallion Service Contract

Babcock Quarter Horses, Inc., agent for the above named stallion, will herein be referred to as the breeder.

1. A non-refundable booking fee of \$\_\_\_\_\_ (included in listed stud fee) is payable with this contract, and the balance of the stud fee: \$\_\_\_\_\_ is due prior to shipping semen or insemination of mare.
2. In the case of a re-breed, mare must be bred at Babcock Ranch. A non-refundable book/chute fee of \$\_\_\_\_\_ is payable with the rebreed contract and must be received prior to mare being bred. In cases in which mare has had difficulty settling, or carrying to term, Babcock Quarter Horses reserves the right to request that a substitute mare be provided, or other breeding options, such as embryo transfer, be considered.
3. A photocopy of registration papers (both sides) must be submitted with contract.
4. Book Fee & Stud Fee must be paid in full prior to shipping of semen or mare being inseminated.
5. The breeding season in force for this contract shall be February 14<sup>th</sup> thru July 14<sup>th</sup>. Semen will not be shipped and mares will not be inseminated outside of these dates. We highly recommend breeding as early as possible in the season.
6. Contract includes a live foal is guarantee. It is agreed that a "live foal" is defined as one that will stand and nurse without assistance after foaling. If the foal is born dead, or the mare is found to be not in foal, it is the Owner's responsibility to notify Babcock Ranches within (7) days. This notice must be accompanied by a statement from a licensed veterinarian. In such case, return privileges will be available the **following year only**. See #2 above for re-breed stipulations. The breeding fee is **non-refundable**.
7. If the mare fails to return for rebreeding the following year, and other arrangements have not been made, then any and all fees paid shall be forfeited, the right to a rebreed is canceled and the stallion owner and or Babcock Ranch is released from all further obligation to this contract.
8. If the mare dies or becomes unfit to breed, the owner may return during this season or the following season only with a substitute mare approved by the stallion owner, without an additional breeding fee (if breeding takes place the following season, a book fee will be due).
9. Stallion Breeding fees are transferable with permission from Babcock Ranches, but are non-refundable. Book fees are non-refundable and non-transferable.
10. It is further understood that should the above named stallion die, or become unfit for service for any reason, then this contract will become null and void and both parties are relieved of any further obligation hereunder. Any moneys paid by owner toward the stallion fee, with the exception of the non-refundable booking fee, can be used toward another stallion's breeding fee or be refunded to the Mare Owner.
11. A "breeders certificate" will be issued upon notification of the birth of the foal, only if all fees are paid, including any past due board bill on any horses owned by the Owner.

This contract is governed by the laws of the State of Texas. All accounts are due and payable in Cooke County, Texas.

13. All expenses (board, vet, farrier, etc.) are due monthly upon receipt of invoice. Balances over 30 days delinquent will be accessed a 1.5% interest charge. All unpaid expenses are due prior to release of horse(s).
14. A Veterinarian's health certificate, clean uterine culture, vaccination & de-worming history, and current Coggins test (within 12 months) shall accompany mare. If medical history is not provided, Babcock Ranch reserves the right to fully vaccinate, de-worm and perform proper tests mare at owner's expense. Mare(s) will be vaccinated, de-wormed, and standard breeding management techniques will be implemented, as deemed necessary, by the attending Veterinarian at Mare owner's expense.
15. The Mare owner agrees that each mare offered for breeding shall be in sound breeding condition, and free from infection and disease. Babcock Ranches reserves the right to refuse mares that are found to be in unsound breeding condition. In these cases, the mare owner may substitute another mare that is in sound breeding condition.
16. The breeder agrees to diligently try and settle the above mare and shall have sole discretion of determining the best method of breeding such mare. If, however the mare does not settle, the Breeder shall be held harmless.
17. I understand and agree that Babcock Ranches and/or its representatives will not be held responsible for accidents, sickness, or death to my mare and/or foal. Furthermore, I agree that the above name parties shall not be held liable for any negligence or errors and that the above named parties may exercise their judgment in supervision and care for my mare and/or foal. I agree that the above named assume no liability whatsoever for Mare and Owners.
18. In the case of an on-ranch breeding, please complete and return to Babcock Ranches a Mare Owner's Specification Sheet. This form specifies whether the mare is to have an embryo transfer performed (in which case an additional embryo transfer contract also must be completed), or if she is to carry the pregnancy. It also specifies which order stallions are to be bred to the mare when using multiple stallions in a single breeding season.

-----**Shipped Semen Breeding Specifics**-----

19. Stallions are collected and semen shipped every-other day regardless of weekends and holidays. Semen will not be collected or shipped on non-collection days. Please refer to breeding calendar for schedule of collection days.
20. Please Note, Mares boarded at Babcock Ranches have breeding priority for semen on any given day, therefore, NO GUARANTEE is made regarding the availability of cooled semen for any specific day. We recommend bringing the mare to Babcock Ranches to be bred if possible.
21. We use 2 shipping methods: Same-day (Counter-to-Counter), which will be delivered to your nearest major airport, & Overnight delivery via Fed Ex. Shipments from some stallions will only be shipped via Counter to Counter; contact Babcock Ranches for more details regarding shipping. All shipments made on weekends and holidays must be shipped via Counter-to Counter.
22. Normally, Overnight shipments are sent via Fed Ex. If you prefer to have UPS delivery instead of Fed Ex, this can be arranged at the same rate with advanced notice.
23. Babcock Ranches is not responsible for any untimely delivery or condition of the cooled semen, as we have no control of conditions after shipment leaves Babcock Ranches. Please notify us IMMEDIATELY if you have any problems with a shipment, as we may be able to assist you with a second shipment the same or next day.
24. Semen is shipped on a first-come, first serve basis. The first person to request a semen shipment for a particular day will get first priority on boxes shipped.

25. I understand and comply with the following:

- a. You must notify office 48 hours prior to needing a semen shipment.
- b. A confirmation call must be made by 10am CST the day before the shipment is scheduled to occur.
- c. Cancellations must be made prior to 8am CST the day of the collection. If your request to cancel is made after 8am CST, Babcock Ranches reserves the right to charge for the shipment.

26. When appropriate, AQHA & APHA Insemination Reports will be enclosed with your shipment. Mare owner is responsible for completing paperwork and returning the appropriate copy to Babcock Ranches and to the breed registry(s).
